- 1. Effective curricula and instruction focus on outcomes.
 - A. Children's learning styles vary.

 - F. Good instructional practices are consistent with valid, current research.
 - G. An effective disciplined environment enhances learning.
 - H. All students have a great deal of potential that can be developed given appropriate earning conditions.
 - I. Some students will require more time to learn than others.
 - J. Students who are proceeding at different rates of learning will have different needs
 - K. Grouping is always an open and fluid process and grouping will change constantly as needs dictate.
