This immunity from liability shall be in addition to and not a limitation of any other immunity provided by law or any absolute or conditional privilege applicable to the disclosure of information or records or the Applicant's consent to the disclosure. Willful failure to respond to or provide the information requested on this form may result in civil penalties or professional discipline.
